Terms and Conditions in Credit Agreement

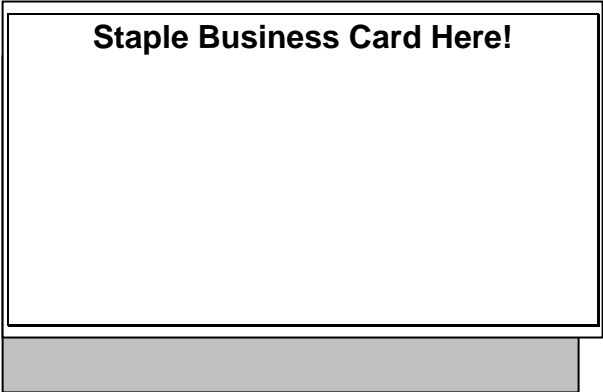

1. Terms of sale are net 30 days. Agents or representatives of Routes Transport International Inc. are not authorized to change or adjust credit terms without written authorization of the Credit Manager, Leonard Koekkoek.
2. All claims against invoices must be made within 30 days after the receipt of goods.
3. Accounts not paid by due date are subject to an interest charge from the date of maturity at the rate of 2% monthly compounded.
4. NSF cheques will be subject to a \$20.00 charge.
5. Failure to comply with these Terms and Conditions may result in cancellation of credit privileges without notice. In the event of any default, Routes Transport International Inc. may close the account and/or accelerate payment of the full balance.
6. Applicant agrees to bear all costs incurred in collecting any unpaid amounts including but not limited to collection suit fees, legal fees and court costs.
7. The information given in this Application and Agreement is warranted to be true and correct and given for the purpose of obtaining credit.
8. The applicant consents to the obtaining of credit and/or personal information as may be required in connection with the credit line hereby applied for or any renewal or extension thereof and to the disclosure of any trade information concerning the applicant to any credit reporting agency or to any person with whom the applicant has or proposes to have financial relations.
9. Upon determination that customer's creditworthiness has changed adversely or does not satisfy current credit standards, Routes Transport International Inc. may close the account, lower the credit limit of the account, or require a personal guarantor for the account.
